d. Nancy Dyo has agreed to volunteer to collect Water Meter Readings.

VI. **Owner's Forum**

- a. Tony shared that the last mowing date is coming up this weekend.
 - i. He thanked everyone for ensuring their grass looks good and is kept low.
 - ii. Christine shared the importance of maintaining lots for fire mitigation purposes.
 - iii. Tony shared that the HP3A boundary is able to be seen on the mowing map that was sent out via email in response to a homeowner asking what the boundary between HP1&2 and HP3 was.
- b. Christine discussed observing numerous dogs not leashed or under owner control and reminded the community that although there is not a leash requirement in the Covenants, that dogs must be under the owner's control.
- c. Christine reminded the community that it is the homeowner's responsibility to ensure that construction debris is cleaned up timely after projects.
- d. John reminded the community that trailers must be kept in garages or storage units.
- e. John reminded the community that we are required to comply with the covenants, but as a community we can vote on certain covenants being added or removed.
- f. A homeowner asked who the 3rd ACC member was and it was shared that Weston Buchanan is the 3rd ACC member.
- g. A homeowner asked about the Briargate-Stapleton update regarding traffic lights or roundabouts.
 - i. One homeowner asked about more information; the Briargate-Stapleton Project link was sent in the "chat link."
 - ii. A homeowner asked if landscaping was going to be completed along Briargate.
 - iii. Christine will follow up about any Briargate-Stapleton updates.
- h. One homeowner explained that new dirt was just put on Poco Road, and it is hopeful the intent is to keep that a dirt road to decrease the amount of thru-traffic from Poco Road to Lochwinnoch.
